GENERAL VOTING DAY will be open to qualified electors of the Village of Lumby on Saturday, November 19, 2011 between the hours of 8:00 am and 8:00 pm at the Village of Lumby Municipal Hall, 1775 Glencaird Street.

Elector Registration (for voting day only registration)

There is no need to pre-register to vote as the registration of all electors for this election will take place at the time of voting. You will be required to make a declaration that you meet the following requirements:

- 18 years of age or older
- Canadian citizen
- resident of BC for at least 6 months immediately preceding voting day
- resident of OR registered owner of real property in the Village of Lumby for at least 30 days immediately preceding voting day, and
- not otherwise disqualified by law from voting.

Resident electors will also be required to produce **2 pieces of identification** (at least one with a signature). Picture identification is not necessary. The identification must prove both residency and identity.

Non-resident property electors must produce 2 pieces of identification (at least one with a signature) to prove identity, proof that they are entitled to register in relation to the property, and, if applicable, written consent from the other property owners.
